RIGHT TO INFORMATION ACT NO. 13 OF 2016

Government Agencies and Private Entities Order No. 164 of 2018

In exercise of the powers conferred on me by paragraph 2(4)(b) of the Right to Information Act No. 13 of 2016, I, the Honourable BOB LOUGHMAN, Acting Prime Minister, make the following Order.
