

#### 2019 Summary

In 2019 the Right To Information Unit carried out the first assessment of government administrated websites to establish an existing baseline of their obligations to Section 6 of the Right To Information Act.

### Websites Assessed: 22

Government administrated websites were assessed using a 15-point checklist method, the highest score was 15 and the lowest being 1. The 34 government websites were assessed and were each given a score between 1 and 15, the individual scores were then summed up against the total score of all websites to give the baseline of 20%.

### Introduction


In 2020 the Right To Information Unit carried out its second assessment of government administrated websites to measure progress made and identify articles that need to be inserted into websites.

9 more websites, from the number the number of websites in 2019, were included in this assessment to make a total of 45 websites. The overall score for the 45 websites is 47%.




