It is understood that through RTI, information are more readily available for public consumption. Through this process RTI have assisted in terms of facilitating information flow while at the same time assist in promoting good governance and transparency within public administration.

The Ministry have dealt with large number of individuals, public and private agencies verbally requesting information directly in relation to national services, decentralization or Boarder and security services. These are information that are vital for general public for which request don't necessarily have to be made through RTI.

In 2023, departments within the Ministry provided to the Office of RTI, Area Administrator's Handbook as a source document that is used in inducting new Area Administrators. Also provided were the updated Provincial and Area Council contacts to the office of the RTI to assist then in their coordination of running awareness across the country.
